Chris Wright re ABT inter counties on the 4th June at NCSC, he is finding it difficult to find a team, Scott Greenfield, Dave Billington and Tracy Meston have offered their services. Phil Moss asked John Perry from CPSA if members scores on the web site could be speeded up. John Perry pointed that this was due to staffing problems that was soon to be resolved. Luke reported from the SER Meeting that Johnny Johnson that some counties have asked for nine man teams for the inter counties, this was not accepted as most counties find it a struggle to find five man teams, plus Lady, Junior and Veteran. Tracy Meston representative from the Management board said that the £1k offered by the SER will be matched by the CPSA for new shooters to attend a competency course not necessarily juniors or colts. Dave Billington reported that after six successful years the inter counties ESK has now been won by Oxford, but watch this space we will be back. The rumours that Dartford SG had lost planning permission is NOT true. If this were true the possible Olympic Games venue would be in jeopardy. The ladies skeet doubles trophy is still missing and must be replaced if not located. If inter counties championships are after county championships teams will be chosen from the CPSA averages.
